- The Company operates mainly in one business segment i.e Elastic.
- The Company is in process of executing an expansion project in two phases by setting up a manufacturing unit at Vietnam by incorporating a foreign subsidiary with a chartered capital of USD 10,00,000 in which the Company shall hold 85%. The Company has remitted an amount of USD 1,00,000 (Rs. 63,57,000/-) towards chartered capital till the quarter ended September 2015.
- The Company has changed depreciation based on remaining useful life of assets as per requirement of Schedule II of Companies Act 2013 which had significant effect of increase in the depreciation expenses in the result of quarter & half year ended 30.09.2015.
- In terms of amended clause 41 of the Listing Agreement, details of number of investor's complaints for the quarter ended 30th September, 2015; opening - Nil, received - 34, disposed off - 31 and pending - 3.
- Figures of the previous year have been re-grouped/re-arranged wherever considered necessary.
